Constitution of Student Council

Article One (Name)

The name of this organisation shall be Student Quality Council, herein after called the Council.

Article Two (Purpose)

The purpose of the Council shall be to:

- 1. Follow the Institutional guidelines
- 2. Participatory role in organising the functionalities of the council
- 3. Involve all students in sharing perspectives regarding curriculum
- 4. Engage all the students to participate in co-scholastic programmes and club activities
- 5. A Democratic decentralised approach method.
- 6. Extend services to the community.
- 7. Act as a liaison between the Principal and the students.

Article Three (Membership)

Section 1: All students shall have the opportunity to be nominated, to vote, and to offer ideas for Councilaction.

Section 2: The members of the Student Council shall be representatives elected by the Students.

Section 3: The Ist College Representative, IInd College Representative, the Secretary-Treasurer are elected by the Students.

Section 4: The principal of the College shall be the final authority over all actions of the Student Council.

Article Four (Representatives)

Section 1: A student who wishes to be a candidate for the Student Council shall:

- 1. Be a good citizen.
- 2. Be open for suggestions and committed
- 3. Intra- Inter personal Relationship
- 4. Be interested in being a Councilrepresentative

Section 2: (Nominations)
