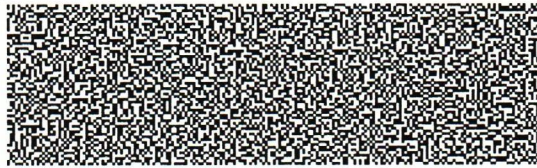
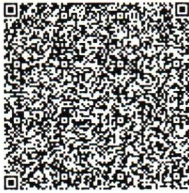

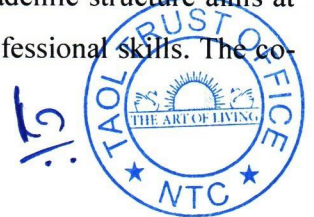

#### 4. Details of Understanding:

The Partners, after due consideration of various aspects, have arrived at the following understanding in respect of the programs mentioned in the earlier paragraphs.

**(4)(i). TAOL undertakes to impart specifically the following programs:  
Life Skills Training (LIST) Program for students (18+ yrs in age)**

- The LIST program runs over for 5 consecutive days for a total of 10 hours (2 hours each day).
- TAOL shall provide faculty to conduct introductory seminars for the LIST programs.

**(4)(ii). SSSCE shall:**

- Provide a clean, well-ventilated hall large enough to comfortably accommodate participants. Audiovisual equipment could be provided.
- Give permission to TAOL faculty to conduct informational seminars on campus to raise awareness among the students and faculty of SSSCE about the LIST program.
- Provide all assistance to TAOL faculty to host the LIST program on campus (accommodation, venue booking, publicizing the programs, and the introductory seminars through all institute communication channels).
- Be responsible to collect the financial contribution from the students/faculty/staff for the conducted programs and transfer the funds to TAOL on submission of invoices as per actuals.

**(4)(iii). Financials:**

- The Program contribution shall be **Rs 700/- per participant for the LIST program.**
- The program contribution for the LIST program shall be borne 50% by SSSCE.
- The LIST program shall be offered to all students. Interested students will voluntarily enroll and pay the 50% of the program contribution themselves.
- The financial contribution shall be transferred by SSSCE to TAOL within one month of the program completion upon submission of invoices.

**(4)(iv). Date of Effect:**

This Memorandum of Understanding will come into effect on 14th march 2023, 2023 and will remain in force for three years till 13th march, 2026.

**(4)(v). Modification:**

The Agreement may be amended in writing by mutual consent between the two Partners.

**(4)(vi). Confidentiality:**

Absolute confidentiality of the information exchanged between the Partners concerning the subject matter of this Agreement shall be strictly maintained.

**(4)(vii). Termination:**

Either Partner may, without any termination obligations and liability, terminate this Agreement for any reason by providing notice in writing of at least 30 days to the other



Partner. Before such termination, the Educational Institution will clear off all money-dues to TAOL.

**(4)(viii). No Legal Obligations:**

The Partners agree that provisions contained in this Agreement do not create any legal obligations between the Partners, save for the confidentiality provisions and Termination provisions in this Agreement.

**(4)(ix). Assignment:**

This Agreement cannot be assigned to any third party, without the prior written consent of the other Party.

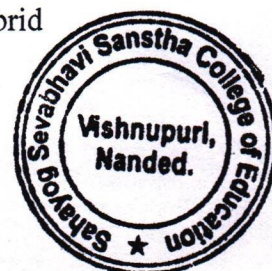
Mutual understanding of the parties agreed and declared as follows:



- h) To motivate students for internship and volunteering (online or offline).

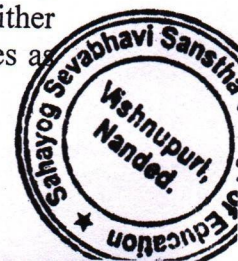
